- <u>Medicaid Matters New York</u>: Statewide coalition representing the interests of New Yorkers served by the Medicaid program
- Commonwealth Fund: Promotes a high-performing, equitable health care system that achieves better access, improved quality, and greater efficiency, particularly for society's most vulnerable, including people of color, people with low income, and those who are uninsured by supporting independent research on health care issues and making grants to improve health care practice and policy.
- New York State Health Foundation: Seeks to improve the health of all New Yorkers, especially people of color and others who have been historically marginalized. We are committed not only to making grants, but also to making a difference beyond our grant dollars: informing health care policy and practice, spreading effective programs that work to improve the health system and make it more equitable, serving as a convener of health leaders across the State, and providing technical assistance to our grantees and partners.

- Communities Together for Health Equity (CTHE): Led by Arthur Ashe Institute for Urban Health, CTHE is a diverse and representative group of over 70 community-based organizations (CBOs) and stakeholders working to ensure comprehensive services that address the spectrum of social determinants of health (SDOH) for over 350,000 communities citywide. Through a unique model of community engagement we aim to ensure community voices are equitably and meaningfully integrated into the healthcare transformation process.
- <u>Coalition of Asian American Children and Families (CACF)</u>: The nation's only pan-Asian children and families' advocacy organization bringing together community-based organizations as well as youth and community allies to fight for equity for Asian Americans and Pacific Islanders (AAPI).
